

Prohibited & Restricted Merchants

NMA recognizes that certain types of merchants carry more risk than others, or require specialized expertise to monitor merchant activity and control risk. For these reasons, the following merchant types are generally excluded unless specific approval from Senior Management is obtained for a particular account. This is not meant to be an all-inclusive. Other types of products and services may be considered prohibited due to their nature. Accounts will be reviewed on a case-by-case basis:

- Unauthorized Ticket Resellers Unfair/Deceptive/ Abusive/Illegal Services or Products Unlicensed Intellectual Property
- Verified MATCH or TOD Listings (Dependent upon category)

Other businesses, while presenting increased risks due to the nature of their products or services, can be structured to mitigate the exposure to loss. Special conditions and rates apply to merchants providing such products or services as detailed later. This is not meant to be an all-inclusive. Other types of products and services may be considered restricted due to their nature. Accounts will be reviewed on a case-by-case basis:

- Companies Organized Outside the United States
- Companion or Escort Services

- Direct Marketing/Subscription/Continuity
- Discounted Health Plans & Cards
- Discount Benefit Packages Med/Dental/RX Card, Travel, Legal

- E-Cigarettes or Vape (non face to face)
